He made all these claims of how many steers he would be slaughtering and bringing over to MMM&S but you have the slaughter numbers from MMM&S and you can see no significant increase of animals. There clearly is a history here and I would encourage you to seek all the facts so that you can make the best decision for MMMS and the Agriculture community in general. Please defer a decision if at all legally possible.

Sabrieta Holland – verbal comments from phone call to the Division:
