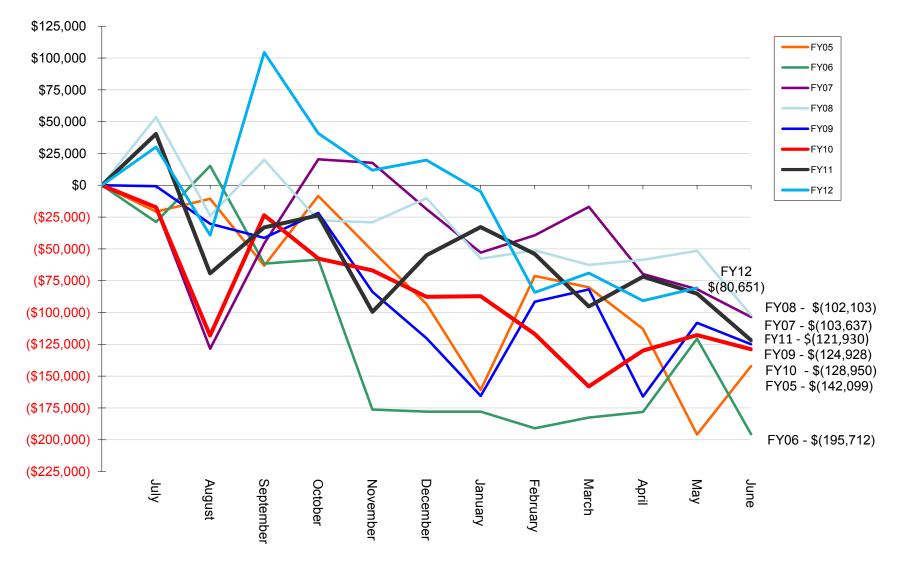

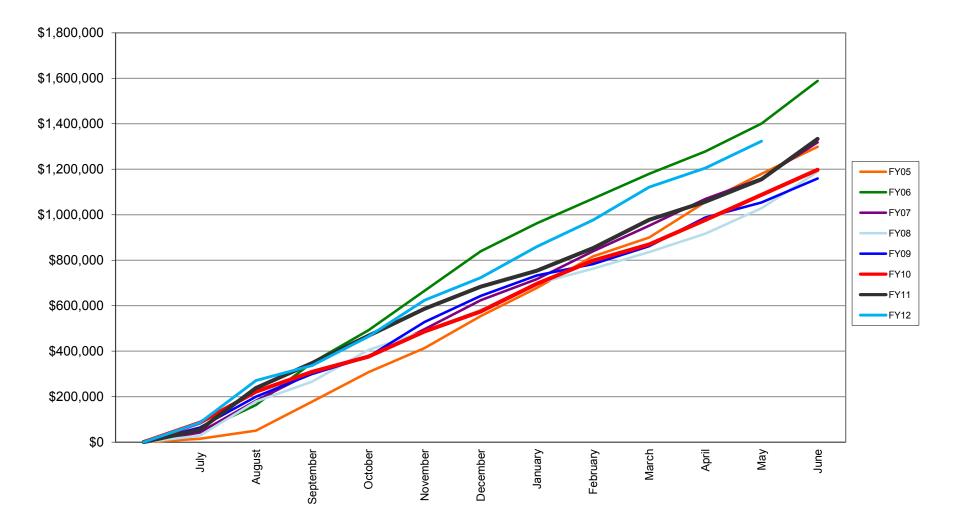

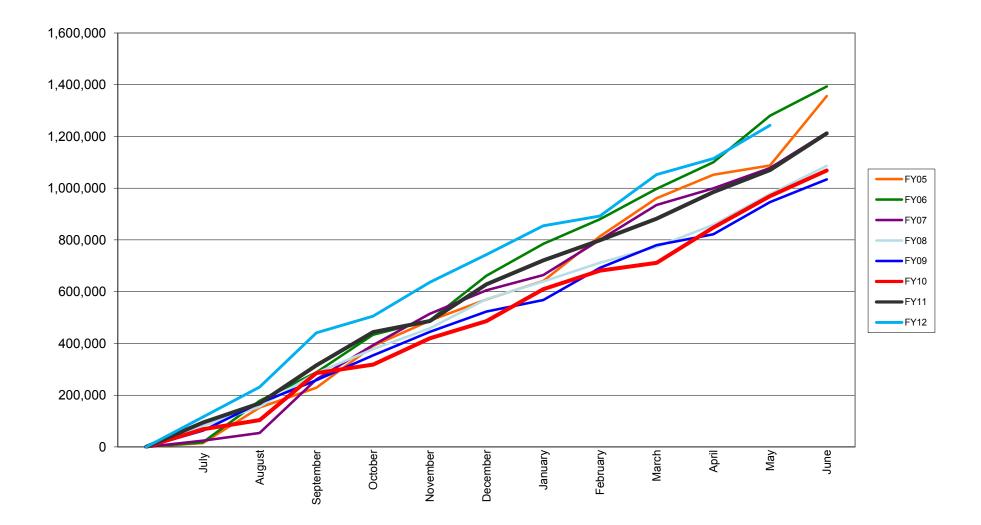
Mt. Mckinley Meat and Sausage Income(Loss) FY 2005 - FY 2012



Mt McKinley Meat and Sausage Cumulative Expenses July 2004 - May 2012



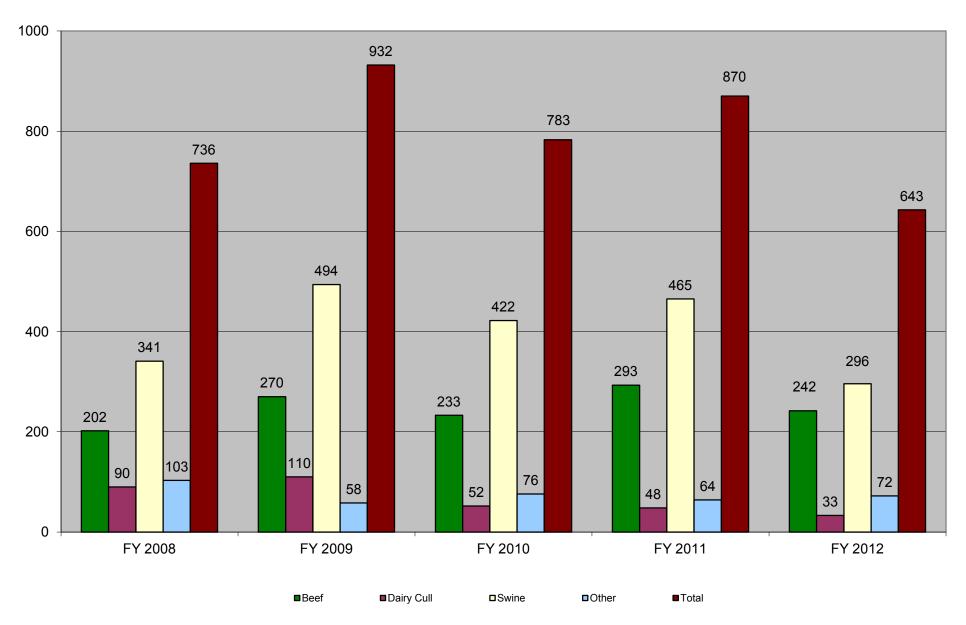
Mt Mckinley Meat and Sausage Revenue Trend July 2004 - May 2012



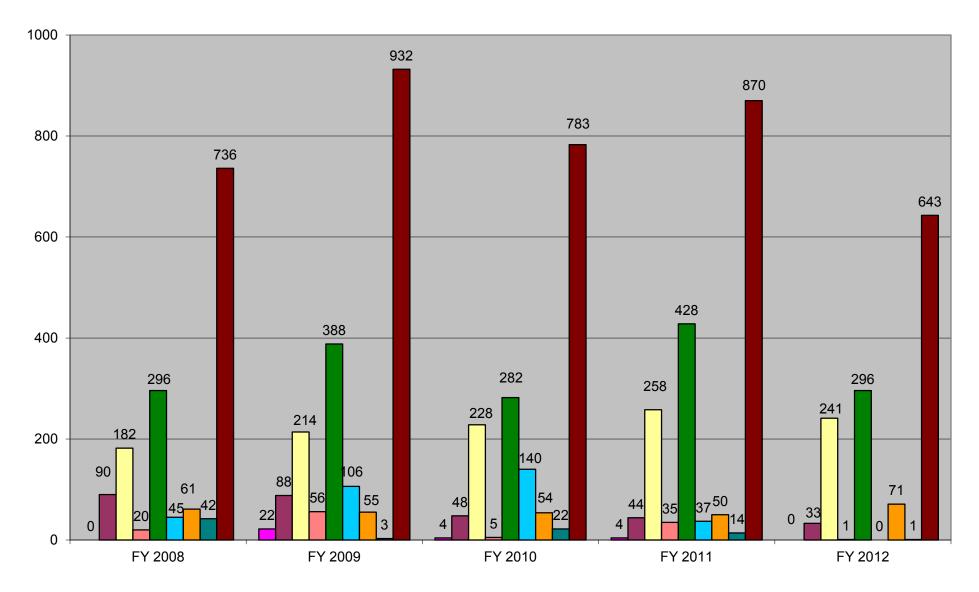
