AAG McFarlane stated he had to prepare the Board's decision from the December 5, 2012 meeting and have it signed before letters to creditors could be sent. He also had discussions with the attorney for Valley Dairy, Inc. including discussions about a possible appeal and this contributed to some delay but the certified letters were sent promptly.

Chair VanderWeele asked how much milk per day was Valley Dairy, Inc. selling maybe around \$8,000.00 in gross sales so there should have been more money to collect.

H. BOARD MEMBER COMMENTS:

Vice Chair Schirack stated on Channel 11 News Anchorage there was a report on the Havemeister Dairy. The report stated the dairy is selling 100% of their milk and Mr. Yoder will be selling milk to the dairy. Carrs Safeway has contacted the Havemeister Dairy to get their milk into their stores.
