These funds are awarded through a competitive review process guided by industry, nonprofit, and government stakeholders. <u>NOTE: THIS</u> <u>SPECIAL COMPETITION IS NOT FOR PURCHASING ANIMALS OR</u> <u>STARTING NEW OPERATIONS.</u>

# PROGRAM OVERVIEW

The State of Alaska, Division of Agriculture is pleased to release this Request for Proposals (RFP) for a special MGFSP competition to address the significant increase in costs for livestock feed, including reduced availability of local hay and grain.

The priority of the grants is to improve available and affordable hay, grain, and other livestock feed to Alaskans who raise livestock to feed their families and local communities. Fixed awards are being offered for small livestock (poultry, eggs, rabbits) in the amount of \$2000 and large livestock (cattle, sheep, pigs, goats, bison, etc.) in the amount of \$5000.

The period of performance (when costs are incurred) is from January 1- September 30<sup>th</sup>, 2024.

Alaska MGFS grants will be determined through a competitive review process and must follow USDA guidelines for eligible spending.

Individuals and organizations may apply and must demonstrate both economic need and how the grant will help increase Alaska's food security. The grants are for existing operations, including urban farms, homesteads, micro, and small farms and are not to be used for the purchase of new animals.


