- A. This form, or a substantially similar form, must be used to meet the State of Alaska's regulatory requirements to record an Affidavit of Initial Production for a new mining operation. If you have questions about this Affidavit of Initial Production, contact the Division of Mining, Land and Water by telephone at 269-8652 in Anchorage or by mail at 550 W 7th Ave, Suite 900, Anchorage, AK 99501-3577. If you have questions about the Mining License Tax, contact the Fisheries and Mining Tax Unit of the Department of Revenue in Juneau at 465-2371.
- B. Throughout these instructions, the term "mining operation" refers to a business enterprise associated with developing, removing, extracting or moving metals, ores, minerals, asbestos, gypsum, coal, marketable earth, stone, sand, gravel or any other mineral deposit on State, federal or private land, but does not include the extraction or production of oil or natural gas.
- C. This affidavit must be recorded by the owner/operator of the property.
- D. This affidavit must be recorded in the recording district where your mining operation is located within 90 days after the date of the initial production. *Failure to timely record the affidavit may result in forfeiture of any right to the three and one-half year exemption from the mining license tax.* (Sand and gravel operations will *not* qualify for the exemption but must file an Affidavit of Initial Production.)

INSTRUCTIONS

- 1. List the names and mailing addresses of all current operators/owners (additional pages may be added).
- 2. List the meridan(s) township(s), range(s) and recording district in which the mining operation is located (additional pages may be added).
- 3. List all property which has gone into production by name and ADL/BLM number, if applicable. You need not list each individual location whenever possible group them: Gold Rush 1-10; ADL 390000-390009; BLM F06781-06789; or Red Frog Project (additional pages may be added).
- 4. State the new mining operation's date of initial production. For the purpose of this affidavit, the date of initial production is generally considered the date initial shipment of mining materials is transported from the mine for sale or additional non-mining processing. Also, production is considered to begin on the date that the mined project is first exported out of Alaska.
- 5. List the type of metal, minerals, or other commodity being produced by the mining operation.
- 6. The person signing the affidavit must print and sign his/her name before a notary or other authorized person. Generally the following persons are authorized to take an oath, affirmation, or acknowledgement in this state: a justice; magistrate; clerk or deputy clerk of the court of the State of Alaska or of the United States; a notary public; and a U.S. postmaster. For a more complete list, see Alaska Statute 09.63.010.

If an authorized person is not available, you may amend the statement in #6 to read as follows: "I, (print your name) swear under penalty of perjury at (location) on (date) that no official empowered to administer oaths is available and that the foregoing statements are true." You must sign this statement. It is advisable, but no required, that a witness sign also. The witness's address should also be included.

RECORD THIS AFFIDAVIT AT THE RECORDING DISTRICT WHERE YOUR OPERATION IS LOCATED WITHIN 90 DAYS AFTER THE INITIAL PRODUCTION DATE.
