Pursuant to 43 CFR §1864, the State of Alaska has filed an application for a recordable disclaimer of interest for the lands underlying the Kisaralik River System including Kisaralik Lake.

It has been brought to our attention that there was a typographical error in Section 1 of our application. Therefore, please accept this document as a request to amend Item 1. Description of Waterway.

The following description should replace the verbiage used in the application.


I. Description of Waterway

This application is submitted for the submerged lands and bed up to and including the ordinary high water line of Kisaralik Lake within Township 03 North, Range 58 West, Seward Meridian and for the submerged lands and bed of the Kisaralik River lying between the ordinary high water lines of the right and left banks of that river from the outlet of Kisaralik Lake within Township 03 North, Range 58 West, Seward Meridian, Alaska, downstream to the location where the river enters the Kuskokuak Slough within Township 09 North, Range 67 West, Seward Meridian, Alaska. This includes the submerged lands and beds of all sloughs, braids and channels that carry water from the navigable Kisaralik River and thus are a part of the navigable river and all lands within the river system permanently or periodically covered by tidal waters up to the line of mean high tide. A map highlighting the river and lake system and legal description of the townships and ranges underlying the river and lake are enclosed as Exhibit 1.
