# VIII. PERSONS TO BE HEARD

Nicole Avecedo and Doug Gasek of the Department of Natural Resources, Division of Parks and Outdoor Recreation, gave a presentation explaining the time lines and procedures leading to final park policy for the Preservation Plan for Independence Mine State Historical Park. They are currently soliciting suggestions for use. Inventory was completed on 12/10/2010, comments will be received until January 2011, and completion is planned for July 2011.

#### X. SUPERINTENDENT'S REPORT

Wayne reported that he was moving employees around to deal with shortages created by loss of personnel through various, unavoidable causes. The Matanuska Lakes Recreational Area renaming is scheduled to be approved on Dec. 15, 2010. Director King indicated he would sign off on recent changes to the board by-laws, and that the new Hatcher Pass use plan restrictions were being challenged by both motorized and non-motorized users, but had been sign off by the head of DNR, Tom Irwin, and were thus in effect.

#### XI. OLD BUSINESS

Following preliminary discussions, a motion was made by John and seconded by Howard to submit a Letter of Comment concerning the Fishhook Renewable Energy project in Hatcher Pass. The letter will consist of "bullet points" assembled and considered by the board from lists provided by John and Wayne. These points will deal with safety, erosion, hydrology, and view considerations and how they will relate to recreational management issues created by the project. Following discussion, both John's and Wayne's points were recommended for inclusion and approved by a unanimous vote of the board.
