**VI. Operations Update:**

Tom gave a Powerpoint overview of the summer operations.

- This summer there were two ACC positions working on the Seward state park trails. These positions were funded by the Recreation Trails Program.
- Projects included major cabin maintenance, and trail work as well as improvements at CHSRA.

Jack updated members on the following item:

- At the beginning of summer, a major wildfire occurred on the Kenai Peninsula. At times up to six state rangers assisted.
- Ranger Jack Ransom transferred to Seward in July.
- Tom Kain has accepted the Haines Ranger position and is transferring to Haines later this month.
- The Seward Park Specialist (8 month season) will be filled later this winter.
- The board agreed to write a letter of recognition for Tom and will consider working on a proclamation from the city thanking him for his service moved.

**VII. Tonsina Creek Watershed Update:**

Members discussed the two abandon mining claims in the Tonsina Creek drainage, upstream from the state park. Members are concerned that there may be hazardous materials on site. The claims have not been mined in years and there is agreement that the sites should be cleaned up.
