# **Federal Legislation news**

This week the House Appropriations Committee <u>approved</u> top line subcommittee allocations for FY24 spending bills that sets funding at FY22 levels. This represents a significant cut for domestic discretionary spending and is well below the spending levels agreed to in the debt ceiling negotiations. The allocations passed along a 33-27 party line vote. Under the allocations, the Interior, Environment and Related Agencies Appropriations Subcommittee, which includes the Historic Preservation Fund (HPF) and several other preservation priorities, would receive a 34.6% cut below current enacted levels. The HPF is currently funded at \$204.5 million and in FY22 was funded at \$173.072 million.

Program authorization expires for the Historic Preservation in 15 weeks. The bipartisan bill H.R. 3350 reauthorizes the HPF through 2033 at \$250 million.

### **NPS Grant opportunities:**

The <u>State, Tribal, Local, Plans & Grants Division</u> is now accepting applications for the <u>Underrepresented Communities Grant Program</u>. Before applying, please make sure that you have read and understand the limitations of each funding program and have carefully reviewed the <u>Notice of Funding Opportunity</u>. The Notice of Funding Opportunity contains all the information you will need to create a successful application.

Congress has appropriated \$1.25 million for the Underrepresented Communities Grant Program (URC) for FY 2023. The URC Grant Program supports the survey, inventory, and designation of historic properties that are associated with communities currently underrepresented in the National Register of Historic Places and among National Historic Landmarks.

Eligible applicants include: State Historic Preservation Offices; Federally Recognized Indian Tribes, Alaska Native Villages/Corporations, Native Hawaiian Organizations, as defined by 54 USC 300309, 54 USC 300313, and 54 USC 300314; and, Certified Local Governments, non-profit entities.

The State, Tribal, Local, Plans & Grants Division is now accepting applications for the History of Equal Rights (HER) grant program. Before applying, please make sure that you have read and understand the limitations of each funding program and have carefully reviewed the Notice of Funding Opportunity (NOFO). The Notice of Funding Opportunity contains all the information you will need to create a successful application. Congress has appropriated \$5 million for the HER program. Grant projects fund physical preservation or pre-preservation of sites associated with efforts to achieve equal rights. The History of Equal Rights grants are not limited to any specific group and are intended to include the broadest possible interpretation of equal rights for any American. Applications are due July 11,

The Notice of Funding Opportunities (NOFO) for NPS FY2023 programs are anticipated spring through fall 2023. NPS recommends applicants set up a saved search on Grants.gov for CFDA 15.929 for Save America's Treasures and 15.932 for Historically Black Colleges & Universities and 15.904 for all other programs to be notified when the opportunity becomes available. The application period is typically 90 days. Therefore, the deadline to apply will be 90 days after the NOFO is posted to Grants.gov. Because the window to apply for funding is limited, we encourage applicants to plan well ahead of the deadline. # **Advisory Council on Historic Preservation news**

The <u>Advisory Council on Historic Preservation</u> (ACHP) is currently seeking feedback from the public on the Secretary on the Interior's Standards for the Treatment of Historic Properties. The ACHP says these comments will help provide a snapshot of the public's views on the application and interpretation of the Secretary's Standards.

The Secretary's Standards identifies four treatments: preservation, rehabilitation, restoration and reconstruction. While comments will be accepted on all four treatments, the ACHP is particularly interested in the application and interpretation of the Secretary's Standards for the Rehabilitation of Historic Properties. Major themes that emerge from the comments will be shared with the Department of Interior and the National Park Service.

The next round of the National Preservation Fund is now open. Enhance your efforts to save the historic places within our community—participate in the National Trust Preservation Funds grant program. This annual program supports local preservation organizations' efforts to **preserve and protect** important places in their communities.

Funding ranges from \$2,500 to \$5,000 and supports preservation planning and educational projects. The next deadline is October 1.

Grant projects have included engineering and architectural consulting services; tours that are accessible via smart devices; and market studies to assist in prioritizing preservation objectives.
